Financial Contribution 2026

Attendance Dues are \$544 per student for 2026 (\$136 per term). These are invoiced for the whole year in Term One and are collected by St Joseph's Catholic School and forwarded to the school Proprietor, The Catholic Diocese of Auckland. Attendance Dues are used to construct classrooms, repay loans for school building works, property-related costs, and insurance of buildings in Catholic Schools in the Auckland Diocese. **Attendance Dues are compulsory and are a condition of enrolment at all Catholic Schools in New Zealand. Please pay the year's Attendance Dues in full in Term One, or Term payments are due by the end of Week 5 of each term, or by regular payments. Paying in full at the end of the year is not an available option. Please pay all dues before 30 November.** If you are experiencing financial hardship please contact our office to make an appointment to see the Principal to discuss this, or you may contact the attendance dues office at the Catholic Diocese of Auckland on 09 360-3040 email acfl@cda.org.nz.

Catholic Special Character Contribution is collected on behalf of the Catholic Education Services Board. They assist our school to provide a Catholic Education for your child through the preservation and enhancement of our Catholic Special Character. This is a tax-deductible donation and is a voluntary contribution.

St Joseph's Pukekohe Development Trust Contribution is collected on behalf of the Trust and is used in our school for improvements to our site and facilities and also for school needs to benefit your child's experience. The suggested contribution is \$200 (\$50 per term) per child (for the oldest two children in a family) each year. This is a tax-deductible donation and is a voluntary contribution which the St Joseph's Development Trust is extremely grateful to receive. (Any unpaid contributions are deleted from students accounts at 31 December each year)

Payment may be made by internet transfer, regular automatic payments, cash, or eftpos (no credit card, no Paywave). **As Attendance Dues are compulsory - all part payments will be allocated firstly to Attendance Dues, and once these have been paid in full, then part payments will be allocated to voluntary contributions.** *If you have more than one student and want your payments split and/or allocated to a particular child please make separate payments referencing each child's name. If more than one student, and you are making small regular payments you could help us (so we have less transactions to process) by alternating your small regular payments.*
